On Tuesday, December 16th, 2025, at 7:00 p.m. Chairman Dan Peters called the regular school board meeting to order. Trustees Ben Lehfeltdt, KJ Fauth, Superintendent Nicole Hanson and Clerk Charly Tatom were in attendance. Guests present were Abby Hansen and Francine Egge. KJ made a motion to approve the minutes for the Board Meeting on November 11, 2025 and the Special Board Meeting Minutes for December 1, 2025, Ben 2nd, all in favor, motion passed.

1. Trustee's report:
